Service Conditions

- 1. The place of work is the Institute's campus. It is presently located in Andhra University, Visakhapatnam, Andhra Pradesh. The Institute is likely to move to its permanent campus located in Gambheeram Village in Anandapuram Mandal, in 2021. The permanent campus is about 20 Km.s from the present (temporary/transit) campus.
- 2. The Institute reserves the right to transfer the faculty to any Campus/Centre that it may open at any other location in India, in future.
- 3. Positions are in regular capacity (full-time).
- 4. Probation period is two years. Age of superannuation is 65 years.
- 5. During the period of probation or after declaration of probation, performance is subject to periodic/yearly review and employment is terminable by either side with up to three months of advance notice or pay in lieu thereof.
- 6. Apart from teaching at post-graduate and doctoral levels; conducting training and executive education programs; and carrying out research and management-consulting work, faculty should be willing to take up responsibilities of academic administration and institution building. Thus, faculty are required to contribute to all four pillars of academics viz. teaching and training, research, service to the Institute and service to the profession.

Selection Process

- 1. A set of Committees constituted by the Institute will carry out the screening and selection processes.
- 2. The process would normally involve (i) short-listing of candidates based on suitability as ascertained from the applications; (ii) seminar-presentation by the short-listed candidates; and, (iii) interview for the further short-listed candidates (i.e. for only those who qualify in the seminar round). It is reiterated that only those candidates who qualify in the seminar are taken forward to the interview round.
- 3. Candidates may be considered for a post lower than that applied for, if they are otherwise found suitable.
- 4. Reimbursement of return economy airfare by the shortest route (domestic sector only) and accommodation (free of cost) will be provided to the candidates who attend the faculty seminar. Family accommodation shall NOT be provided.
- 5. The Institute reserves the right to include in the recruitment process, those suitable candidates too, who may not apply.
