Current and future vacancies are at the levels of **Professor, Associate Professor and Assistant Professor**, in regular capacity. Only Indian nationals should apply.

<p><b>Selection Process</b></p> <ol style="list-style-type: none"> <li>1. A set of Committees constituted by the Institute will carry out the screening and selection processes.</li> <li>2. The process would normally involve (i) short-listing of candidates based on suitability as ascertained from the applications; (ii) seminar-presentation by the short-listed candidates; and (iii) interview for the further short-listed candidates (i.e., for only those who qualify in the seminar round). It is reiterated that only those candidates who qualify in the seminar will be taken forward to the interview round.</li> <li>3. Candidates may be considered for a post lower than that applied for, if they are otherwise found suitable.</li> <li>4. Interviews would be held online (in virtual mode). If the interviews are held with physical presence, reimbursement of return economy airfare by the shortest route (domestic sector only) and accommodation (free of cost) will be provided to the candidates who attend the faculty seminar.</li> </ol>
<p><b>General Instructions</b></p> <ol style="list-style-type: none"> <li>1. Candidates are advised to visit the website of IIM Visakhapatnam (<a href="http://www.iimv.ac.in/careers">www.iimv.ac.in/careers</a>) regularly for updates. Amendments, corrigenda (if any), will be placed on the Institute website only.</li> <li>2. Candidates from disadvantaged sections and women are strongly encouraged to</li> </ol>

3. Relaxations as per GOI norms will apply for candidates from disadvantaged sections.
4. The Institute reserves the right not to fill up any, some or all position(s).
5. Qualifications acquired must be duly recognized in law.
6. Applicants should satisfy the experience criteria as on the date of their applications. Duration of PhD (and experience acquired therein) and self-employment will not be counted for the purpose of experience. Only officer and higher-level experience would be counted, in case of candidates from other than academic institutions.
7. Mere fulfilment of qualifications and experience does not entitle a candidate to be short-listed. The Institute reserves the right to restrict the candidates to be called for the selection process to a reasonable number based on relevant criteria, higher than the minimum prescribed.
8. Applications should be complete in all respects. Additional sheets as needed may be used and referenced suitably. All information furnished MUST be based on supporting documentation. Incomplete, incorrect or sketchy applications are liable to be rejected.
9. Candidates employed in organizations or institutions (including autonomous bodies) under the Government (Central or State); or Public-Sector Undertakings (Central or State) must produce a proper Relieving Letter at the time of reporting for duty.
10. The Institute will communicate only with short-listed candidates. No correspondence from applicants shall be entertained.
11. Canvassing in any form will be a disqualification.
12. In all matters of selection, recruitment, appointment and service, the interpretation and decision of the Competent Authority of the Institute shall be final and binding.
13. Disputes (if any) shall be subject to jurisdiction of the competent courts of the city of Visakhapatnam and/or Andhra Pradesh, India.

Where applicable, certificate (where applicable, with validity as on closing date of applications) issued by the Competent Authority clearly showing the category (OBC/SC/ST/EWS/PwD) to which the applicant belongs MUST be attached with the application. Except such Category Certificate, no copy of any other certificate or supporting documentation need be attached/submitted along with the application. Such proof would be sought later, ONLY from short-listed applicants.
