 - IIMV FIELD aims to promote, develop, and nurture the culture of entrepreneurship and innovation by way of facilitating, enabling, creating, fostering, supporting, funding/investing, mentoring, managing the entrepreneurial efforts, initiatives, endeavours, and ventures. After the host institute, IIM Visakhapatnam started its operations in 2015, IIMV FIELD has been steadily making an impact in the ecosystem.
 - In **2018**, IIMV Started Entrepreneurship activities in the Incubation Center with the **Women Startup Program** in partnership with NSRCEL of IIMB.
 - In 2019, the Incubator got recognized by MEITY as a G3 centre in the TIDE2.0 Program. We are the only third generation IIM and one of the five IIM's to be a part of this program.
 - In **2020**, IIMV FIELD got incorporated as a section 8 company.
 - In 2021, IIMV FIELD was recognized by NSTEDB, DST and was awarded the NIDHI Accelerator Program.
